<sup>\*</sup> A special mention has to be made concerning the PNDR: Many measures support actions that tackle "Environmental conditions, change and risk", "Development of rural non-agricultural products/activities" that can be seen as close to the PA 2 and 3 of the CBC ROBG) and the "Training for farmers" that can be seen as close to the activities supported under the PA 4 of the CBC ROBG if the beneficiaries, the "farmers" are SMEs. As such, the PNDR is correlated with the CBC supported actions under the PA 2, 3 and 4 but a special attention will have to be paid during the selection of projects supported by the CBC ROBG 2014-2020 in order to avoid the double financing and ensure that support under the ERDF is coordinated with the supported under the EAFRD. Given the fact that the supported measures under the PNDR, which tackle aspects, related to TO5, 6 and 8, are not yet well defined. It is too early to clearly identify, at this stage, measures that may "overlap" with the CBC.
