The Ministry of Environmental Protection and Natural Resources of Ukraine (hereinafter – the Ministry) presents its compliments to the Ministry of Environment, Water and Forests of Romania and has the honor to inform the following.

The Ministry would like to inform the Ministry of Environment, Water and Forests of Romania that the Ukraine is conducting a strategic environmental assessment for the Danube River Basin Management Plan (2025-2030) (RBMP).

The RBMP is a national-level state planning document that defines the main environmental objectives for surface water, groundwater and areas (territories) to be protected and a set of measures to achieve them.

To date, the international approach to the implementation of RBMP has been characterized by transparent approach in the context of informing potentially affected Parties, despite the demonstration of no impact on people and the environment.

The RBMP information does not identify the possibility of a significant impact on the territory of neighboring countries.

As no significant adverse transboundary impacts have been identified, information on the RBMP and the report on strategic environmental assessment is being provided to you by the Ukraine Party for information purposes only, while maintaining the transparency of the strategic environmental assessment procedure.

If the Romania Party will participate in the transboundary consultations, as stipulated in Article 10 of Protocol on Strategic Environmental Assessment to the ESPOO Convention, please inform the Ministry before 6 April 2024.
