- 7. Bids must be delivered to the address below on or before 03rd October, 2024, 12:00 local time. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on 03rd October, 2024, 12:00 local time.
- 8. All Bids must be accompanied by a Bid-Securing Declaration.
- 9. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
